RoHS / WEEE Compliance Statement

Woodland is committed to providing its customers with safe and environmentally friendly electric and electronic products that are compliant with the European Union (EU) RoHS Directive (Restriction of Hazardous Substances) and the WEEE Directive (Waste Electrical and Electronic Equipment). This document provides information about Woodland products sold into EU countries relative to those directives. It will be reviewed annually for applicability and changes in the Directives.

RoHS II Directive

The European Union has established requirements for Restriction of Hazardous Substances (RoHS) in all Electrical and Electronic Equipment (EEE). The details of this directive can be found at <http://ec.europa.eu>.

Certification of Compliance

Woodland certifies that to its knowledge the EEE products that it provides conform to the requirements of the European Union's Restriction on Use of Hazardous Substances in EEE RoHS II Directive 2011/65/EU, including all amendments.

Declaration of Conformity (DoC) and Technical File Documentation

To comply with RoHS II, all CE marked products require a Declaration of Conformity (DoC) and that a technical file be made available to authorities upon request. Woodland will provide the DoC and technical documentation, including Certificates of Compliance demonstrating compliance to the banned substances of RoHS II:

- Lead (Pb)
- Mercury (Hg)
- Cadmium (Cd)
- Hexavalent chromium (Cr +6)
- Polybrominated biphenyl (PBB)
- Polybrominated diphenyl ether (PBDE)
- Hexabromocyclododecane (HBCDD)
- Bis (2-ethylhexyl) phthalate (DEHP)
- Butyl benzyl phthalate (BPP)
- Dibutyl phthalate (DBP)

Based on our own internal analyses, vendor supplied analyses, and/or material certification of the raw materials used in the manufacture of Woodland EEE products, we declare that all products currently comply with and conform to RoHS regulations.

CE Mark

RoHS II is a CE mark Directive requiring the CE mark to demonstrate compliance to RoHS II. No other mark indicates compliance to RoHS II. The addition of the CE mark is the responsibility of Woodland and is done so after specified product safety and conformance testing is performed. The CE mark is applied to finished EEE that have met the specifications set forth by Woodland.

WEEE Directive

Under the European Union WEEE (Waste Electrical and Electronic Equipment) Directive, applicable Woodland goods shipped after 13th August 2005 (marked with the crossed out wheellie bin symbol shown on the right) must be disposed of in a manner which minimizes the impact of electrical and electronic goods on the environment, by increasing re-use and recycling and reducing the amount of WEEE going to landfills.



Applicable Woodland products are designed to ensure that the equipment can be dismantled and the components and materials are recoverable. The above symbol on the product or its packaging indicates that this product must not be disposed of with other household waste. Instead, it is the purchaser's responsibility to dispose of the waste equipment by handing it over to a designated collection point for the recycling of waste electrical and electronic equipment. The separate collection and recycling of waste equipment at the time of disposal will help conserve natural resources and ensure that it is recycled in a manner that protects human health and the environment. For more information about where waste can be dropped off for recycling, please contact the local authority or the distributor that supplied your product(s).

Implementation of the Directive into law is the responsibility of each individual Member State but in all cases, it is the responsibility of 'the producer' of the goods to ensure the goods are disposed of in accordance with these regulations at the end of their life. The producer is defined as being either the manufacturer of the goods (if sold in the country of manufacture) or the importer of the goods into the Member State in which they are sold.

Sales direct to end-users and distributors of Woodland products in European Union Member States

The end-user or distributor is defined as the importer for these sales and bears the responsibility to dispose of the goods according to the regulations of the individual Member States where the goods are sold. Woodland has no obligation for the disposal of these goods.
